We had this information through in 2012 as intelligence and it was shared with Op Pallial in November 2012 but it would appear that it has never been recorded as a crime (I have checked our local system, PNC and PND. I apologise for the lack of detail but this is all I have: **In 1987 a Cheshire MP, Mr Peter Morrison, was taken off a train in Crewe following an allegation of abuse of a young male on the train. The MP's name is on the list of those involved with North Wales child abuse.**

The suspect we have is Sir Peter Morrison b, [redacted] **DPA** 44 no details of an address other than he lives in Chester.

Please can you record and send me the crime number for our records?
