***** Investigation Update *****

Soper was found guilty by a Jury of 12 (Majority Verdict's on all counts 10/2) on Wednesday 6th
December 2017, he was sentenced for all 19 counts of the indictment on Thursday 21st December 2017
by HH Judge Bates -

The total sentence was eighteen (18) years imprisonment.

It is constructed as follows: on Counts 1 and 2 (both multiple incident counts) twelve (12) years,
concurrent to each other.

Counts 1 – 2 relate to the charges of Buggery against **RC-A622**

On Counts 3 & 5: No separate penalty x 2 (Indecency with a child – **RC-A622**)
Count 4 (multiple incidents) Four (4) years, concurrent to both Counts 1 and 2 (Indecent Assault
against **RC-A622**)

On Counts 6 & 7: Six (6) months, concurrent to each other but consecutive to the above (Indecent
Assault on male against **RC-A8**)

On Counts 8, 9 & 10: Six (6) months, concurrent to each other but again consecutive to the above.
(Indecent Assault on male against **RC-A608**)
