In 2014 a former pupil [RC-A618] made allegations against MAESTRI, he denied this offence and no further action was taken due to lack of evidence, however MAESTRI did admit an incident involving [Name Redacted] [Name Redacted] declined to make a statement. In 2009 MAESTRI was convicted of one count of indecent assault in relation to allegations made by [RC-A11] As states above MAESTRI was found not guilty of a further allegation in 2011 by [RC-A599]

Dom Laurence SOPER was the Abbot at Ealing Abbey between 1991 and 2000, he stepped down before his second term as Abbot ended. Shortly after the new Abbot Martin SHIPPERLEE received a letter from [Name Redacted], he made a sexual allegation against SOPER when he had been in [DPA] [Name Redacted] was seeking compensation from the Abbey / Benedictine Order and advice was sought from Ealing Abbey lawyers (the only [Name Redacted] [DPA] [DPA] born [DPA] 1979 [DPA] [DPA]). In 2004 [RC-A622] contacted police in relation to allegations of rape and sexual assault against SOPER at St Benedicts School and a youth hostel in Somerset in 1973-4. In 2004 SOPER was no longer teaching at the school and the DETS screen shows he was initially still at the Abbey, but was later in Rome. The CPS made the decision to take no further action, though [RC-A622] was spoken to again in 2011. In 2010 [RC-A601] called police making an allegation against SOPER, further allegations were made by [Name Redacted] and [Name Redacted]. SOPER was in Rome at the time these allegations, he returned to the UK and was arrested and interviewed. SOPER denied the allegations, he stated he was in charge of discipline at the school from 1979-83. After his arrest in 2010, further allegations were made by [Name Redacted] (incident at [DPA] [DPA] [Name Redacted] (met at Ealing Abbey) and [Name Redacted] and of inappropriate behaviour by [Name Redacted]. The allegations against SOPER range between 1975 to the 1990s and as stated above there are also allegations against SOPER by [RC-A613] and [RC-A11] [RC-A11]. SOPER failed return on bail on 08/03/2011 and remained wanted until his arrest in May 2016 in Kosovo. Further allegations have now been made by Peter HARTNETT, [RC-A8] [RC-A8] [RC-A616] [Name Redacted] and [RC-A619]

A number of single strand allegations were made against monks and staff at St Benedicts School and Ealing Abbey. In 2005 [RC-A421] made allegations against [RC-F41] the initial incident was in relation to [RC-A421] complaining he had constipation on a trip to [DPA] in 1984 and [RC-F41] placing his finger in [RC-A421] anus, [RC-A421] made a further complaint of being forced to perform oral sex. [RC-F41] admitted the first incident stating he had been told to do this for constipation by his GP father, he denied the second incident but did admit to being sexually attracted to boys; [RC-F41] was found not guilty of the second offence in 2007. The CARLILE report states [RC-F41] was barred by the Secretary of State of having any contact with children and subsequently moved away, however Ealing Abbey website still lists him as living there. In 2005 Peter-Paul HARTNETT contacted police in relation to allegations against [Name Redacted] [Name Redacted] in 1971, [Name Redacted] died in 1975. Peter-Paul also named a number of other victims and suspects, suspects include MAESTRI, [Name Redacted] and a male believed to be PEARCE. In 2010 [RC-A423] made an allegation from the early 1970s against [RC-F46] [RC-F46] no further action was taken, but [RC-F46] was placed under restrictions and a strategy meeting held over this incident and comments he made to a girl in 2004. In 2010 [RC-A604] [RC-A604] made an allegation against teacher Stephen SKELTON, the incident occurred in 1983 and [RC-A604] states he told his parents who spoke to the school at the time, he states nothing was done and SKELTON remained at the school. SKELTON was convicted of offences against [RC-A604] and another boy, who attended a school SKELTON later taught at. [RC-A25] [RC-A25] contacted police in 2011 with allegations against priests [RC-F96] [RC-F307] [RC-F307] & [Name Redacted] the incidents occurred between 1963 - 8. [RC-F96] and [Name Redacted] are deceased. [RC-F307] was still at the Abbey 2011, a contract was made to restrict his activities, [RC-F307] refused to sign the contract. There was insufficient evidence to proceed against [RC-F307] and the restrictions were lifted. In 2011 [Name Redacted] contacted police regarding an allegation against an unknown priest headmaster in 1936, [Name Redacted] also said other boys were sexually abused. In 2011 [RC-A12] made an allegation against [Name Redacted] [Name Redacted] between 1967-74, no further action was taken as the allegation amounted to corporal
