**CS-A118** b. **DPA**/2002 – **DPA** – CSE Marker

#### Crime – IP

**DPA** – 14/04/2017 - Sexual Assault On A Female Aged 13 And Over

MO - During the hours of day light inside a derelict building, 15 year old male suspect grabs 14 year old female victim and asks her for a kiss. Female refuses and male puts his hand down her waist and touches the top of her vagina. The female then pulls away and the male grabs her a second time and attempts to bend her over. Female then makes off from the scene.

**CS-A118** – 14/07/2018 submitted in relation to this crime. The initial disclosure stated that after school **CS-A118** was at the disused building of the **Sensitive/Irrelevant** Leisure centre **Sensitive/Irrelevant** i/c **CS-B1356** b. **DPA** 2001. Other friends where in the area but the pair were alone together. **CS-B1356** has grabbed **CS-A118** and asked her for a kiss, **CS-A118** has pulled away and said no. **CS-B1356** has then forced his hand down **CS-A118**'s trousers and touched the top of her vagina. **CS-A118** has told **CS-B1356** to get off and pulled away a second time. Whilst walking away **CS-B1356** has then grabbed her around the waist and tried to bend her over. **CS-A118** has then pulled away once more and left the area, meeting up with her friends. **CS-B1356** had no permission to touch **CS-A118**

#### Intelligence

**DPA** – 15/09/2018

Information received that **CS-A118** **DPA** 2002 has befriended **Name Redacted** **DPA** 1986 and is now regularly at the address caring for her children.

**DPA** – 27/07/2018

**CS-F257** – **DPA** 1967 has been cautioned 27/07/18 for taking a child as of to remove him from the personal having lawful control. This relates to **CS-F257** breaching his child abduction warning notice regarding having no contact with **CS-A118** – **DPA**/2002.

**CS-F257** – **DPA** 1967 breached these conditions by allowing her in his vehicle on 25/07/18 and taking her to **Sensitive/Irrelevant** McDonalds then returning her to **County Durham**. On the date in question **CS-A118** **DPA** /2002 was a missing from home/concern after leaving a suicide note at the home address.

**DPA** - 12/07/2018

Officers have served Child Abduction Warning Notice on **CS-F258** **DPA** 1996 h/a **DPA** **DPA** Bishop Auckland **DPA** following mispers **CS-A118** **DPA** 2002 and **CS-B726** **DPA** 2005 being found at the h/a.

**DPA** 12/07/2018

Officers have attended H/A of **CS-F257** - **DPA** 1967 to issue a CAWN.

**CS-F257** has transported youths **CS-A118** **DPA** 2002 and **CS-B726** **DPA** 2005 in vehicle **DPA** (Ford | FOCUS **Sensitive/Irrelevant**) to Bishop Auckland, which has then facilitated the youths to go missing for a number of hours in Bishop Auckland.

**DPA** - 10/07/2018

At approximately 15:15 on 09/07/2018 **CS-A118** - **DPA** 2002 and **CS-B726** **DPA** 2005 entered the property of **DPA**

According to Red Sigma, this is the home address of **Name Redacted** **DPA** 1987 and **Name Redacted** **DPA** 1986.

**DPA** - 10/07/2018

Officers had cause to attend **DPA** Bishop Auckland on 10/07/2018 following a report to Police of **CS-A118** - **DPA** 2002 missing from her home address.

Males at address were **Name Redacted** **DPA** 1987 and **Name Redacted** **DPA** 1996.

Males were informed that officers were there for MFH **CS-A118** and straight away headed upstairs to get **CS-A118** and could be heard talking stating they weren't lying for her when Police clearly knew she was at the address.

During the time speaking with persons **Name Redacted** **DPA** 1982 was also present.

The house had a smell of cannabis but nothing could be seen.

**DPA** - 01/07/2018

**CS-A118** **DPA** 2002 was seen coming out of the back garden of **address** **address** when questioned **CS-A118** stated that she was getting cigarettes from **CS-B727** - **DPA** 2001.
