

<p>1 Friday, 23 October 2020 2 (10.30 am) 3 (Hearing in closed session) 4 (3.30 pm) 5 IN OPEN SESSION 6 MR ROGER MICHAEL ROCK (continued in open session) 7 Examination by MR ALTMAN (continued in open session) 8 MR ALTMAN: Mr Rock, just a few more questions, please. 9 We've been asked for you to give evidence on one 10 discrete issue, something I have already touched upon, 11 but in open session, about the 28 November 2001 meeting 12 with you in the course of Magnolia. 13 On Wednesday of this week, Mr Wynne, who was one of 14 the officers in Magnolia, gave evidence in open session, 15 and what he said was this. He was asked this question: 16 "Question: At that meeting on 28 November, were the 17 allegations made against Lord Janner discussed at all, 18 or even brought up? 19 "Answer: I'm sure they would have been. I wouldn't 20 say that they were hidden in any way." 21 In particular, that's about A19 and possibly A6: 22 "Question: That's not quite the question that 23 I asked, Mr Wynne. Do you recall sitting around the 24 table and saying, 'Oh, by the way, A19 has made 25 allegations against Greville Janner'?"</p> <p style="text-align: center;">Page 1</p>	<p>1 "Answer: I could say, 'Yes, I do'. I could say, 2 'No, I don't'. But, either way, it's not reflected in 3 the notes. 4 "Question: I just want to understand your 5 recollection before we look at what the notes do or 6 don't say. Do you remember now, at that meeting, 7 Greville Janner and the allegations against him being 8 brought up? 9 "Answer: I don't. 10 "Question: You don't recall one way or the other? 11 "Answer: No. 12 "Question: Do you accept that, on the basis of 13 the documentation available to the CPS, the CPS weren't 14 informed about JA-A19 and A6's allegations? 15 "Answer: No, I don't accept that." 16 So that's what Mr Wynne had to say to us. In 17 essence, he is not prepared to accept that you were not 18 informed about A19 and A6's Janner-related allegations 19 during the course of that meeting on 28 November 2001. 20 What's your evidence about that? 21 A. I was not informed of those allegations against Janner 22 at that meeting. Had I been, I would have immediately 23 ended the meeting and referred the matter to the Chief 24 Crown Prosecutor, because I would have had to refer 25 certainly that part of the file, and possibly more of</p> <p style="text-align: center;">Page 2</p>
