CIRCUMSTANCES OF INCIDENT / ANY OTHER INFO

CS-A26 and her siblings have been subject to child protections since September 2016 due to escalating concerns in respect of the children, most notably CS-A26 and Sibling of CS-A26. There were concerns noted in regards to Mother of CS-A26's chaotic lifestyle and the impact that this has had on the children's presenting issues, namely in respect of drug use and a relaxed approach towards boundaries and risk.

CS-A26 is frequently going missing from home. Upon return CS-A26 refuses to provide any details of her whereabouts or who she was with.

CS-A26 is associating with a number of young people who are known to YOS and linked to theft, drugs and violence. The young people are CS-B304, Name Redacted, CS-B700 and Name Redacted.

A young person in the same care home as Name Redacted told Catch 22, CS-B700 CS-B700 (17) is "shagging CS-A26 and only using her for Sex".

Sensitive/Irrelevant

Contact received on the 11/06/17 in regards to [CS-A26] [CS-A26] was taken to hospital by [Father of CS-A26] on the 11/06 after [CS-A26] had self-harmed. [CS-A26] had superficially cut her **Sensitive/Irrelevant**

[Father of CS-A26] reported that [CS-A26] returned to [Mother of CS-A26]'s at 05:00 Sunday morning following being missing. [CS-A26] phoned [Father of CS-A26] and he collected her from her mums. When [Father of CS-A26] got to [Mother of CS-A26]'s [CS-A26] was outside crying, he then took her to [Merseyside] [CS-A26] is due to assessed by CAMHS on the 12/06/17.

[CS-A26]'s behaviour in school continues to be an issue. [CS-A26] on a PSP which she is currently failing due to not meeting any of the agreed targets. [CS-A26] is often verbally abusive to staff and peers which results in her being excluded from school. [CS-A26] is now on her last chance at school, if she is excluded again alternative education will be sort.

[CS-A26] has recently has had frequent water infections.

[CS-A26] told the school nurse [Name Redacted] she is having regular palpitations, anxiety and she cannot sleep. When [Name Redacted] discussed her recent risk taking behaviour, [CS-A26] was reluctant to discuss this advising she can't tell anyone what is going on. [Name Redacted] then established something is going on with [CS-A26] and asked if there is anyone who she could speak to, to which she advised she cannot tell anyone what is going on due to what it will lead to.

During a home visit to Dad on the 29.06.17 he advised he has seen messages on [CS-A26]'s phone saying "fancy cheering me up" – the number is [DPA]. Unknown who this was from.

Further messages found on Facebook messenger from [CS-F144] (NFD) – Messages sent on the 24/05.17.

[CS-F144] – "wanna make some cash"

[CS-A26] – "How"

[CS-F144] "doing something for me"

[CS-A26] – "What"

[CS-F144] – "well for a fuck"

[CS-A26] – "nah"

[CS-F144] – "Why would have been cash in hand"

[CS-A26] – "How much we talking sexy"

CS-F144 – “depends on how good you are and what I will ask you do”

CS-F144 – “So you on it then. So you wanna have a wee for cash”.

Dad reports CS-A26 phone then broke. CS-A26 now has her phone back and it is unknown whether further messages has been sent as Dad as not been able to get on the messenger after this.

Further to this Name Redacted from school spoke with CS-A26 on the 29/06/17. She asked her to answer this “is there something going on in your life that if you told on them they would get in trouble” to which CS-A26 said yes. CS-A26 refused to discuss this further with Name Redacted

Social worker is going to see CS-A26 in school on the 30/06/17 to discuss all of the above with her.

CS-A26 is open to Catch 22 and her allocated worker is Lindsey Kelly.
