### FINANCIAL REPORT – as at 31 March 2023 (Full Year – 2022-23)

#### 1. OVERVIEW

The information in this report sets out the expenditure for the Final position of the 2022-23 financial year ending 31 March 2023, with a further breakdown of costs in relation to staffing and expenses below. The expenditure for the half year is **£6,971,878**.

\* Operating costs for the Operation Hydrant team which receives referrals from the Inquiry. Operation Hydrant was set up to co-ordinate the response of police forces for non-recent child abuse. This budget included cost for staff redundancies which will not be required following successful placement of staff into roles, hence cost being lower from last quarter.

\*\* Estates costs are showing as favourable expenditure primarily as a result of cost of dilapidations (accommodation cost estimated for repairs at the end of tenancy) carried forward as an estimate in year as advised by Commercial Property advisers, where successful negotiations have delivered significant savings, therefore budget is favourable due to the release of sums. Savings have also been achieved by delivering work in house, without the need for additional accommodation.
