There were also concerns about Realing's behaviour – police intelligence was that he

No further action was taken due to lack of evidence/information and it was agreed at					
this time that RC-F84 would not be suspended. RC-F84 is					
aware of this allegation.

In 2008 RC-F84 went to DPA A novice monk has issued a 'civil writ' against RC-F84 for unwanted sexual advances,

In October 2009 RC-F84 returned to Downside Abbey and a novice monk there made allegations of RC-F84 touching and rubbing him during private					

driving lessons. The novice monk was possibly not asked whether he wanted a police inquiry. RC-F84 is aware of this complaint.
RC-A102 has re-contacted the Roman Catholic Diocese this year (June 2010) and insists he has spoken to the police this year to re-state his allegations although the police have no record of this.
Police
Lindsay Shearlock said there was no trace of the 2005 allegations made by RC-A102 on the police database (although there was no electronic system until 2007). It was likely to have been a paper record and may not have been formally recorded as a crime, hence the current no trace result.
Police hold intelligence on RC-A102 regarding his own sexual behaviour in public (see above). He has a caution in 2005 for possession of an offensive weapon (knife) in a public place and a conviction for a public nuisance offence (unwelcome sexual behaviour in a public toilet) in 2000. The police advise staff caution, ie, do not visit alone. There is no information on the police database regarding RC-A102 s alleged contact with the Police.
RC Diocese Safeguarding Office
Jane Dziadulewicz said that RC-F84 s DPA which gives him access to the school and monastery sites, so the children see him as a 'trusted adult'. He is currently in the USA and due back in a few days.
RC-F84 has admitted sharing a bed with RC-A102 but stated that no sexual activity took place.
The Abbot has taken the following action
<ol> <li>Drawn up a code of conduct, although at the time of this meeting it had not been seen by the RC Diocese Safeguarding Office, and there was correspondence to indicate this was being breached. (Note: The code of conduct was seen by the RC Safeguarding Office after the meeting).</li> </ol>
<ol> <li>Commissioned a psychological assessment, not a risk assessment. The Abbot says he has referred this to Phoenix for a risk assessment although they have not received this yet.</li> </ol>
If the novice monk says no to police action then the Roman Catholic Diocese can appoint an independent person to undertake an internal investigation (this is likely to be Tony Domaille, an ex-police officer).
The RC Diocese Safeguarding office are concerned that the new Abbot does not understand the safeguarding process. The Abbot is also the school Chair of Governors.

Long history in relation to the allegation and who has been informed				
June 2007 – Abbot Aidan spoke to RC-F80 who admitted what had happened.				
2009 – A letter was received from the Abbot by RC-A117 saying that     RC-F80 did not deny it; he had been told to discontinue using Facebook and that his position 'at school' was under review.				
(There has been no report to the RC Diocesan Safeguarding office in relation to this).				
RC-A117 also alleges abuse by RC-F118 at Ampleforth in Yorkshire – he is now deceased.				
RC-A117 has agreed to make a complaint to the police but will need great sensitivity due to her vulnerability.				
Current Role				
RC-F80 is DPA DPA due to the allegations – now only at the Abbey; parents, staff, pupils at school and other monks have been told he is unwell and in need of total rest.				
RC-F80 has been told he has been withdrawn from school due to a 'complaint' against him – no details given. The Police have requested that no information as to their involvement be given until the alleged victim has been interviewed.				
Communications issue				
The RC Diocesan Office usually agree a press statement with the police communications team at the outset of any allegation being made. The school communications officer is Gordon Pearce. The police have requested that no press statement be issued by the Roman Catholic Church until RC-A117 has been interviewed and an investigation plan made.

## Father Nicholas White - dob DPA 45

Rc-A117 has told Jane Dziadulewicz that some time ago she had been told that Father White was accused of sexual abuse against 2 or 3 children when Housemaster in the 1980s at Downside School.

Andrew Hobbs was aware of this allegation and the internal investigation; it was not furthered in that no contact was made with the Police although apparently Father White was 'given treatment'. A strict code of conduct was put in place and Father White was restricted to the Abbey. Mr Maidlow Davis was aware these issues were not reported to the police.

#### Current role

Secretary to Abbot. No contact with school at all.

#### RECOMMENDATIONS

- 1. Jane Dziadulewicz to talk to the Abbot about the investigation process and ask to see the file.
- 2. If the police have not previously been informed, Jane Dziadulewicz to contact Lindsay Shearlock.

#### **OVERVIEW RECOMMENDATIONS**

Jane Dziadulewicz will tell the Abbot that all previous historic cases (pre 2003) need to be reviewed by the Diocesan Safeguarding Team or an independent person, in line with national RC procedures.
