Met with Mother today. Apparently RO-A10 and RO-A9 were picked up at Rochdale Toilets yesterday. They were offering their bodies for sale/offering to masturbate any man who might fancy it. He was to be charged with gross indecency but that may not happen given that both RO-A9 and RO-A10 gave the Police a statement about these
