COMMENTS - e-mail received from DS2039 SHAW; This relates to an allegation made by Carol DEAKIN regarding [NO-A716]. Having met with Social Services regarding [NO-A716] it was felt that it would not be in the best interests to interview [NO-A716] as it would set back her current progress. [NO-A716] has been described as a girl [Irrelevant] functions of about a 6 or 7 year old child. The allegations were made regarding an incident from approximately 2004 and [DPA] has a very short attention span and difficulties in remembering dates/times and places. [NO-A540] was unable to tell anyone where this is alleged to have taken place. There were no independent witnesses to the alleged incident. [NO-A540] has not disclosed this to anyone else since and it is felt that the best interests of [NO-A540] are not to interview her and put her through any form of investigation.
