1. Criminal Compensation should deliver closure to all survivors of abuse.
2. The CICA did not deliver for me because of the 1979 Oct same roof law.
3. This is the most important questions it says it all with the paragraph. I went to great lengths to obtain a CICA recognition. The police for five years and twenty nine years [illegible] would not investigate my abuse. If you obtain [illegible] from CICA tribunal from the [REDACTED] in [REDACTED] Tribunal Court, you will see how the police treated me.
4. None have delivered any amount of compensation to myself.
5. The main reason for my not getting justice is the fact for 6 years and twenty nine years the police [illegible] and have not investigated my case.
6. No idea prob because of the police or the amount of paper work needed to fill in.
7. Lawyers don't want to know unless you have or your abuser has lots of money.
8. The advantage is the CICA is government. The disadvantage is [illegible] to be the police.
9. For me it was the police in [REDACTED] would not investigate the abuse aimed at me and possible others I tried to help plus there was the 1979 act same roof law.
My father the main abuser had many friends in the law and high ranking police as friends.
Time limits have [illegible] into the facts over the last 6 years, even though the police today knew I went to the law in [REDACTED]
10. The amount of paper work and liaison with the police.

11. None came my way Oct 79 law.
12. I would like my day in court **[illegible]** but the police will not act.
13. For me it was the Oct 79 same roof law.
14. For the police to investigate and **[illegible]** the wider same roof law and make access to the Civil Court easier.
Because the police would not for 6 x 35 years not investigate. I have not had the justice I deserve.
15. Again it would be easier if the CICA could link with the Criminal Civil Court.
16. The **[redacted]** Rape and Crisis Centre in **[redacted]** gave me years of support and **[illegible]** together with my doctor.
17. **[illegible]** the **[redacted]** have been very supportive together with Napac, a god send.
18. The whole system seems now to be aware of the problems people have been let down.

For me it took 3 years to achieve a reasonable result with CICA because the **[redacted]** police would tell CICA there was no evidence. In court in **[redacted]** it **[illegible]** the police had not over-stated our investigation at all.

Yet they kept telling CICA there was no evidence.

The law on how police investigate must change as we are seeing up and down the country. In the last 2-3 years because of all the historic abuse in the press it has made me even more ill. With the fact no institutions have pulled together to help **[illegible]** victims.
