ALLEGATION

Subject attends St Benedicts School which is a private Catholic School for boys. On Friday 12th June 1992, subject was taken to his GP a Dr. [Name Redacted] where it was alleged that he was indecently assaulted by his Headmaster Father David on Thursday 4th June 1992. Apparently on that Thursday Father David had taken him and the whole class for a Health Education lesson, the subject being Child Abuse. After the lesson [RC-A595] was picked out by Father David who took him to his office and started to ask him questions about whether he was beaten by his father and what with. Father David it has been alleged then asked the subject to pull his shorts and pants down and started rubbing his bottom. He then pushed and prodded the entrance to the child's bottom with his finger. An appointment was then made for the subject to be medically at N.E.H. by Dr [Name Redacted]. His findings were no medical evidence of sexual abuse or physical abuse. Arrangements were then made for a full statement to be taken from the child on Monday 15th June 1992. Social Services were advised not to inform suspect of the allegation until the statement was taken. Enquiries continue.
