| <p>Country: Germany Nature of the Offence: Indecent Assault on a female child under 16 Historical Offence: Offences have taken place on British Army Base in Germany when offender was serving in the Army. Aggrieved was watching television with her father on the couch when he has hugged her inappropriately resulting in him touching her breasts and back over her clothing. Aggrieved has ended up being sat on top of her father and felt that his penis was erect. Offender has proceeded to inappropriately kiss his daughter. Result: 13 years + 27 months consecutive imprisonment Organisations involved in the investigation and prosecution: Lancashire Police & British Army.</p> | |

| <p>Country: Egypt Nature of the Offence: Rape of a female aged 16 years or over Offender is known to victim as partner. Allegation occurred on holiday in Egypt. Victim remained in hotel room with child whilst offender went out drinking. Offender returned in the early hours of the morning. Offender approaches victim who was laid on the single bed with her daughter who was sleeping. He lay next to her on the bed and vaginally penetrated her with his penis from behind. She elbowed him causing him to stop but the movement woke her daughter. Result: NFA</p> | |
| <p>Country: Germany Nature of the Offence: Rape of a female aged 16 years or over Victim and suspect who were in a relationship have gone for a 3 night stay in Berlin. On the first night they have been drinking in local bars and at some point victim has been to the toilet and felt very strange from her feet upwards and generally unwell. She believes that her drink was spiked by someone. Her next memory was waking up on the floor at the foot of her bed in the hotel room with no clothes on her bottom half. | <p>Country: New Zealand Nature of the Offence: Sexual Assault on a male child under 13 Whilst a child was on a football tour to New Zealand victim was sexually assaulted by football coach in bedroom of host family. Abuse included the touching of genitals over and under clothing. Result: Suspect Deceased (same suspect as above)</p> | |
| <p>Country: Hungary Nature of Offence: Rape of a female aged 16 years or over A disclosure was made to a staff member at Royal Preston Hospital that she had been raped. The staff member then reported this to Police and the possible victim then changed her mind and stated to Police that she had not been raped. Result: NFA</p> | |
