

Mr N. Fairbairn, M.P. Fordell Castle, Fordell Estate, By Dunfermline.

Since the announcement of the Queens Birthday Honours List I feel I must write to ask you why Mr Fairbairn should get away with assault, and then receive a Knighthood.

On the evening of Saturday 13th September 1986 at 6.50p.m. my daughter Name Redacted was returning home. Mr Fairbairn approached Name Redacted, shouted and repeatedly swore at her and struck her across the face and chest. The Police were called, and they interviewed six witnesses who confirmed Name Redacted story. The Police Sergeant from Dalgety Bay Station would not go to Mr Fairbairns home on the Saturday evening. He said he preferred to wait until the Sunday when Mr Fairbairn would have sobered up. The Police Sergeant said he did not want to remain a "tea boy" for the rest of his working life. The police returned on the Sunday and informed us that all the details would be forwarded to the Procurator Fiscal in Dunfermline, but since this incident we have been unable to find out what is happening.

My family and myself are extremely concerned about this situation, and we are now wondering if there is one law for M.P's and another law for members of the public. I have supported the Conservative Party since I was old enough to vote, but I am very distressed when I see this man getting away with behaviour which is no better than that of a football hooligan.

I trust that you will look into this matter, and I look forward to receiving your reply.
